### RELEASE AND ASSUMPTION OF RISK FORM FOR OUTDOOR EDUCATION

I, the undersigned, am aware that during the outdoor activities described in this form and in which I am participating, under the arrangements of Alpine Outdoor Education and its parent organizations, Alpine Ministries, Alpine Bible Camp and Appalachian Bible College, its agents, employees, and associates, certain risks and dangers may be present or occur, including but not limited to the outlined risks following:

I am aware that during the outdoor education class(es), high ropes course, low ropes course, swings, zip lines, or climbing walls in which I am participating under the arrangements of Alpine Outdoor Education, that certain risks and dangers may be present or occur, including but not limited to hazards of falls or slips while walking, hiking, or climbing on terrain that is not improved, hazards of falling from heights, rope entanglement, falling rocks and other debris, burns or injuries related to the handling or use of ropes and other climbing equipment, accidents or injuries related to the use and handling of sports and game equipment, injuries inflicted by reptiles, insects, or any other animals, the forces of nature, and travel by automobile, van, bus, or other conveyance.

In consideration of and as part payment for the right to participate in such adventure recreation, other activities, use of recreational facilities, and the services and food, if any, arranged for me by Alpine Outdoor Education, its agents, employees, and associates, I have and do hereby assume all of the above hazards and other related risks which may be encountered on said outdoor education activities including activities preliminary and subsequent thereto, and I do hereby hold Alpine Outdoor Education, its agents, employees, and associates harmless from any and all liability, actions, causes of action, debts, claims and demands of every kind and nature whatsoever which I now have or which may arise from, or in connection with my outdoor education or participation in any other activities related thereto. I hereby irrevocably consent to and authorize the use and reproduction by Alpine Outdoor Education, or anyone authorized by Alpine Outdoor Education, of any and all photographs which may be taken during the activity in which I am participating or other activities related thereto, for advertisement or promotional purposes, without further compensation to me. All negatives and positives, together with the prints shall constitute property of Alpine Outdoor Education or those authorized by Alpine Outdoor Education to take pictures or videotapes, solely and completely. I further agree to obey and follow all rules, regulations, and instructions of Alpine Outdoor Education, its agents, employees, and associates. The terms hereof shall serve as a release, indemnification, and assumption of risk for my heirs, executors and administrators and for all members of my family, including any minors accompanying me.
